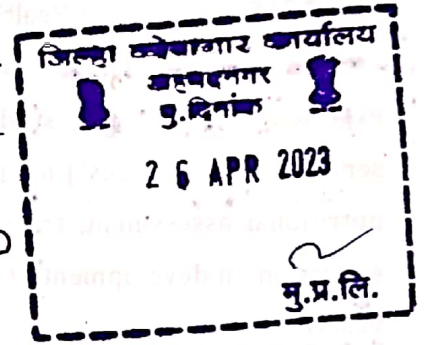

Memorandum of Understanding

THIS AFFILIATION AGREEMENT is entered into by and between

College of Nursing, a constitute of Nityaseva Hospital College of Nursing, Shevgaon
(hereinafter "Educational Institute") and, the esteemed Saideep Healthcare & Research

Pvt. Ltd. Hospital, Ahmednagar. Together these are the "the Parties" to this Memorandum of Understanding. The Parties agree that their respective organizations and relevant contracted agencies will endorse and adhere to this Memorandum of Understanding at all levels of operations.

BACKGROUND

Nursing aims to improve and maintain the wellbeing of an individual in society by providing interventions that will help the individual to maintaining health and preventing illness. It plays a critical role in supporting growth and development and access to learning, recreation and work. For this reason, access to well-planned, responsive and targeted nursing services for those individuals who need them is vital for maximizing their potential to achieve successful long-term social, educational and vocational outcomes.

Scope of the Memorandum of Understanding

WHEREAS, The Educational Institute desires to provide clinical exposure to its Students enrolled in Bachelor and Masters of Nursing Program.

WHEREAS, The Saideep Healthcare & Research Pvt. Ltd. Hospital, Ahmednagar is willing to make available its facilities and resources for educational training, research and clinical experiences to nursing students which will necessarily include provision of nursing services ("the Services") for Patients: which includes nursing care, physical examination, nutritional assessment, training on activity of daily living, nursing therapies, psycho-education on development of self-help group, conducting research studies and educational visits.

THEREFORE, in consideration of the mutual covenants contained herein, the Educational Institute and Saideep Healthcare & Research Pvt. Ltd. Hospital, Ahmednagar agree upon as follows:

1. The best interests of the patients are the primary concern and purpose of the Services.
2. The Parties will develop and foster collaborative working relationships and make the best use of available resources to provide the Services.
3. Best practice and professional standards will be adhered to provide the Services.
4. The Parties agree to work flexibly together and to provide the Services.

5. Neither party, in performing its responsibilities and obligations under this Agreement, will discriminate against any person because of said person's race, creed, religion, national origin, sex or age, and disability.

6. This Memorandum of Understanding and the Operational Guideline will serve as the basis for Local Level Agreements. The Local Level Agreements will outline how health and education services will work together to deliver quality services.

Confidentiality

The Parties acknowledge that disclosure of information is subject to the Official Information Act 1982, the Privacy Act 1993 and the Health Information Privacy Code 1994.

Each Party will consult with the each other before disclosing information relating to operational matters covered by this Memorandum of Understanding, as required by law, and each Party will only disclose that information in accordance with the law.

The Term and Termination

1. Clinical training and experience of the students will be carried out in Students batches at the Hospital as mentioned in the syllabus i. e. 1 month in the 1st year, 2 months in the 2nd year and 1 month each in 3rd and 4th years, total 5 months.
2. Nityaseva Hospital College shall pay Rupees Two Thousand per trainee per month as a non-refundable amount in advance 2 weeks before starting of each training month mentioning the names of all trainee students against the amount.
3. In the event of increase in the duration of training at the affiliated hospital, the charges shall be same i. e. Rs. Two Thousand per each month, maximum Rs. Sixteen Thousand only, irrespective of the number of months if more than total eight months.
4. Proper prior planning will be done with the Hospital before sending every batch of Students for the clinical training and experience.
5. Clinical training & experience will be effectively supervised by the clinical instructors/Tutors of the College if applicable.
6. The overall responsibility regarding the students and their behavior will be on the clinical instructors and the tutors of the college.
7. All the staff and the students must follow the rules and regulations laid by the Hospital. The college students and the staff shall not have unlimited access to all the patients in the hospital except the designated teaching beds only.

8. The college students and the staff shall take every care to handle all Hospital equipment carefully and only under the direct supervision of the Hospital staff. Any mishandling leading to breakage, malfunction of the equipment shall attract a fine or full reimbursement of the price of the equipment.
9. The College staff and the students shall observe all the universal precautions for infection control and use the needed barrier technique/device/equipment. In case of any exposure to any form/mode of infection including a needle stick injury, the Hospital shall be liable to provide only the First Aid treatment. If any more treatment is required, the college has to pay the charges as per tariff.
10. Also, the Hospital shall not be held responsible if the College staff or students suffer any injury (mental or physical), exposure to infection and the loss of any valuable belongings of the College staff or the students in the Hospital premises. The hospital shall not be responsible for any compensation for any of the aforementioned eventualities.
11. The Hospital authority will have every right to inform and suggest necessary action if there is any sort of misbehavior from the students and the staff.
12. The College students and staff should always co-operate and support all the activities and programs conducted and organized by the hospital whenever & wherever needed by the hospital management.
13. The Hospital shall issue a 'Posting Completion Certificate' to the students only after the completion of the requisite clinical training and practical experience. The hospital reserves the right to withhold the posting completion certificate in case the student has not completed the required classes/training hours etc. as specified.
14. The Hospital and College will work together hand in hand giving good nursing care and facilities to the patients.
15. In the event Nityaseva Hospital College does not deposit the aforementioned amount SHRPL shall not accept the trainees.

Execution

This Agreement and any amendments thereto shall be executed in duplicate copies on behalf of Saideep Healthcare & Research Pvt. Ltd. Hospital, Ahmednagar by an official of each, specifically authorized by its respective Board to perform such executions. Each duplicate copy shall be deemed an original, but both duplicate originals together constitute one and the same instrument.

IN WITNESS WHEREOF, the duly authorized officers and representatives of the Saideep Healthcare & Research Pvt. Ltd. Hospital, Ahmednagar, have executed this Agreement at Ahmednagar, on this 13th day of January, 2024 valid for the next 5 years till January 12, 2029 and this agreement can be terminated by either party with prior one month notice period.

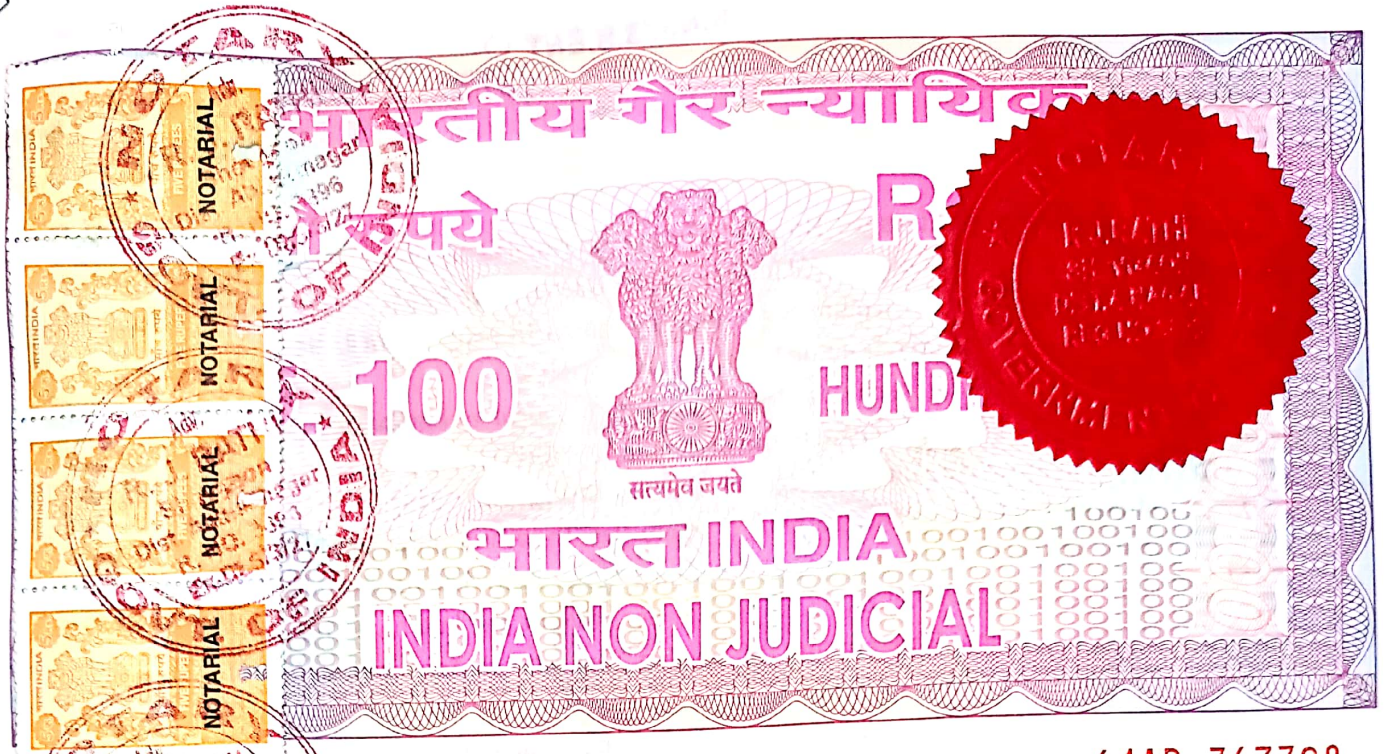

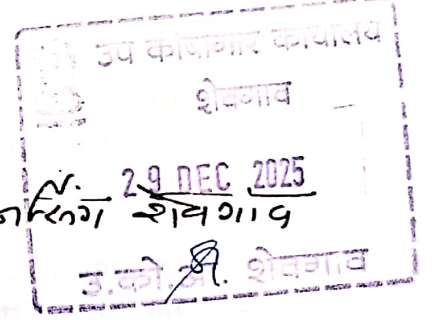

Here by, mutually execute an agreement which reads as under:

1. College Name: Nityaseva Hospital College of Nursing Shevgaon, Dist- Ahilyanagar is running a Nursing College affiliated to MUHS Nashik Since 2023.
2. As a part of the curriculum prescribed by Indian Nursing Council, New Delhi, Nursing students need to take training in Psychiatry discipline.
3. SPUR will Provide such training (theory & practical either or both) to the nursing students of the said college, in the discipline "PSYCHIATRY"
4. The Nityaseva Hospital College of Nursing Shevgaon, Dist Ahilyanagar will pay the affiliation charges of Rs. 25000/- (Twenty five Thousand only) to SPUR at the time of granting permission for affiliation. Apart from that, Nityaseva Hospital College of Nursing Shevgaon will pay posting fees per student per batch , at the time of posting commencement. The amount of posting fees per student will be decided by the management of the Society.
5. The affiliation will be valid for only one batch per course per year
6. This agreement will be valid for a period of three years. Effective date will be the date of signing of the MOU by both parties.
7. The terms of this agreement are however, subject to revision / modification after a period of 12 months, every year.
8. This agreement can be terminated by either party, by giving 45 day's notice in writing or proportionate amount in lieu thereof.

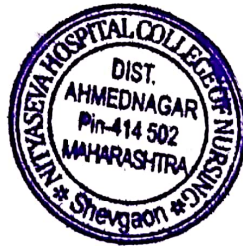

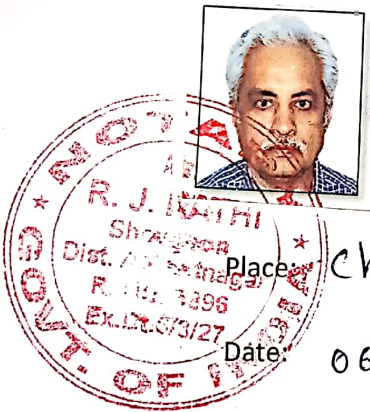

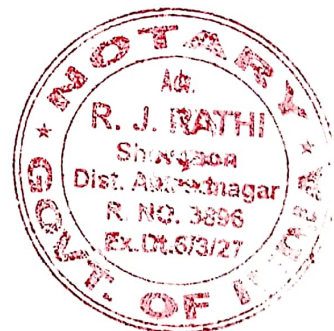

Rules and Regulation

1. Affiliation will be given to the instruction only for three consecutive years. At the end of this period , affiliation needs to renewed
 2. It is compulsory for the students to come for the posting , to our hospital for clinical experience . if in case, in any year, student do not come for posting , the affiliation automatically stand cancelled.
 3. Topic of the lectures, date and duration of posting, names and number of students at posting, name of the supervisor a complying the student is to be informed to the hospital one month before the posting schedule commences.
 4. The students are expected to be punctual , regular, attentive and willing to work in Psychiatry.
 5. Students should be accompanied and supervised by the college supervisors.
 6. Student are not allowed to drink or smoke in hospital premises.
 7. Students are expected to follow the instructions given at the hospital by seniors. Any misbehavior with the patient and /or staff shall not be forgiven.
- Payment structure for Affiliation and posting with Society for Psychiatric Update and Research, Shanti Nursing Home.
1. Charges for affiliation Rs.25000/- are to be paid immediately after getting the written permission of affiliation from us. It has to be paid by DD/ Cheque in the name of "Society for psychiatric Update & Research" Payable at Aurangabad. After which a certificate for affiliation will be issued. This affiliation will be Valid for 3 Years after which a renewal of the same has to be done the further period.
 2. Tuition fees per student per posting will be Rs.700/- for RGNM students and Rs.1000/- for BSc, / P.B.BSc./ MSc Students. It has to be paid by DD/ cheque in the name of "Society for Psychiatric Update & Research" Payable at Aurangabad, at the time of commencement of posting.
 3. Examination fees for External/ MUHS examination , if conducted at Shanti Nursing Home , is Rs.100/- per student per exam.
 4. This fee does not include accommodation and food charges. Those arrangements have to be done on personal level/ institute level.
